- 3. Notice that the page where these documents are available is called "Standard Terms and Conditions of Use". In the English version of the game and main page, the link is also labeled "T&Cs". I see this line of arguing as fairly unimportant. Rather, the point that possibly needs improving is our reference to the paragraph that the player breached, so that there is no confusion. This however should not render our proceeding as invalid.

- 3. "Terms & Conditions" is actually a collection of legal terms applying to our services. So saying "there are no t&c" is not correct. What we were referring to is within our General Terms of Use, which is part of the collection of our Terms & Conditions.
- 4. I realize you were not asking for logs, however there is still a limit of how much detail we can go into. I can see why you would not accept our reason for withholding details, however it is a sensible reason. I will try to be a bit more descriptive. Your game actions (and this is not limited to fleet movements) show a degree of consistency and level of activity over a long period of time that is simply not possible for a human to perform. I'll ask a question of my own here. In the last month or so, in your daily routine, did you ever need to make a break of playing OGame for whatever reason?
- 5. This is a statement, not a question. One that I don't entirely agree with. Cases like this can each be different.
- 6. I can confirm that the ban reason on your game account in Leda NL was not changed after it was first issued.
- 7. I believe this is why we are still discussing. Nonetheless, if we don't reach a conclusion you can accept, then yes, seeking legal counsel is an option for you.
- 8. As you know, much of that information falls under protection. I would not encourage this course of action, however in a case where I believe we've given a just penalty, this is not a threat that would persuade me in any capacity to step back from my position. We are here to protect the integrity of a fair game within the rules.

- 5) Automation bans are made by conjecture and indirect proof.

These were my main points in the previous 2 messages I wrote this morning. After some thought, there I feel that we should speed this up, cause you basically went back a couple of days and, again repeated what chaosk wrote.

Theres some more questions:

6) Why was the ban reason for the 2nd account in Leda changed? I did not even open a ticket regarding this account - as it doesnt have any kind of priority to me. Its weird how, me explaining a average ogame day for bellatrix, somehow changes the ban reason on an account thats not being talked about

Since I am not looking forward to be spending "months" negotiating with you untill we finaly get some information; here are some points to speed it up:

- 7) I've spend money on the account, so you can say there is a monetary investment on my part. Writing that "you will not share anything" that explains my ban, is unaceptable to a paying customer. I feel that Gameforge is pushing me to seek external council on this matter. That is a step that I rather not take, as it is kind of silly considering we are, still at the start of this conversation.
- 8) In the event that internal and external means are exhausted; I will be publicizing everything I legally am allowed to about this case. This will include ticket transcripts, and any information I gathered elsewhere, or will be given at a later date. Due note, that this not something I want to do; It is something that Gameforge will be forcing me to do. While this might cause removal from any platforms Gameforge/Ogame has; at this point in time I rather not play a game, or be active in a community of a game that simply removes players without reason.

Yes, without reason - what has been said to me so far does not prove me anything. The only thing I can think of is that last years addition to the admin tool has flagged my accounts as being suspicious.

With the intent to speed up, its also time to throw more of my assumptions in writing; Seeing as how I have 3 active accounts, (Indus, Bellatrix and Leda) 2 of them being banned, one not being banned - I can assume the following:

My assumption is that im being banned for automating something in regards to sending fleet. The account that is not banned, I do very little on. hence my conjecture about this.
